

## THREE-DAY TECHNICAL LEGAL SERVICES COURSE

### Methodology:

*Personal issues* - buying and selling of residential property, landlord and tenant agreements, wills and probate, divorce and family matters, personal injury claims and criminal litigation.

*Commercial work* - helping new enterprises get established, advising on complex corporate transactions (including mergers and acquisitions) and business-related disputes.

*Protecting the rights of individuals* - making sure they receive compensation if unfairly treated by public or private bodies. In this three-day course, you will have the opportunity to use & practice OSINT techniques with the guidance and assistance of our specialist trainer.
